

Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, January 14-30, 2024, naming Barrett-Jackson Holdings LLC (15555 N. 79th Place, Suite A, Scottsdale, AZ 85260) as the certificate holder. The following must be listed as additional insured: Barrett-Jackson Holdings LLC, Barrett-Jackson Auction Company LLC, Jackson Productions, Jackson Family Foundation, IMG Auction Company, LLC, City of Scottsdale, Westworld of Scottsdale and U.S. Bureau of Reclamation, and RDK Enterprises Inc.

Rainprotection Insurance Program

The auto declarations page must show active policy dates, vehicles covered, and a minimum Bodily Injury/Property damage liability of a combined single limit of \$150,000
