## BANK LETTER OF GUARANTY FORMATS

Below are examples of our preferred Bank Letter formats. If you are using the "Alternate Bank Letter" format, we will need to contact the bank 2-3 days prior to the start of the event to verify the funds are still available.

You must pay for vehicle purchase(s) with a check written or a wire transfer against this account only (account number must appear on check). No other checks will be accepted.

If your bank will not provide these formats, please contact Bidder Services at 480-421-6694 to discuss an alternate method of payment.

<u>Bidders using non-U.S. bank accounts</u> should use the "Wire Transfer Guaranty" format opinion. Personal or business checks drawn on international bank accounts cannot be accepted.
