

Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, April 15-21, 2024, naming Barrett-Jackson Holdings LLC (15555 N. 79th Place, Suite A, Scottsdale, AZ 85260) as the certificate holder. The following must be listed as additional insured: Barrett-Jackson Holdings LLC, Barrett-Jackson Auction Company LLC, Jackson Productions, Jackson Family Foundation, IMG Auction Company, LLC, South Florida Fairgrounds, Palm Beach County Expositions, Inc. and RDK Enterprises, Inc.

Rainprotection Insurance Program

Auto Liability Insurance

If automobile insurance will not be included on your certificate then you must supply a copy of the insurance for any vehicle that will be driven onto the site for unloading, loading or display purposes. The auto declarations page must show active policy dates, vehicles covered, and a minimum Bodily Injury/Property damage liability of a combined single limit of \$150,000
