## BANK LETTER FORMATS

Below are examples of our preferred Barrett-Jackson Bank Letter formats. If you are using the Verification of Funds Bank Letter Format, we will need to contact the bank 2-3 days prior to the start of the event to verify the funds are still available.

You must pay for vehicle purchase(s) with a check from the account number referenced on the letter, no other checks will be accepted.

Regarding the letter format, the Bid Limit must be written as a numerical value. Letters written as "\$2,000,000" will be accepted whereas letters written as "7-figures" will not be approved.
