## BANK LETTER OF GUARANTY FORMATS

Below are examples of our required Bank Letter of Guaranty formats. If you are unable to use the **PREFERRED BANK LETTER OF GUARANTY FORMAT**, we will accept our **ALTERNATE BANK LETTER FORMAT** as an alternative. *NOTE: If you are using the Alternate Bank Letter Format, we will need to contact the bank 2-3 days prior to the start of the event to verify the funds are still available. If the amount of your bank letter is under \$100,000, once the funds have been verified you will be able to pick up your bidder badge at the "pre-registered bidder pick-up" located on-site in the auction office. If your bank letter is for an amount above \$100,000, your bidder badge will be mailed out with your credential packet.*

**Bidders using non-U.S. bank accounts:** Letters must be written on bank letterhead, using the "Wire Transfer Guaranty" format. Personal or business checks drawn on Canadian bank accounts cannot be accepted.

**Please Note:** You must pay for vehicle purchase(s) with a check written or a wire transfer against **THIS ACCOUNT ONLY** (account number must appear on check). No other checks will be accepted. **If your bank will NOT provide these formats, please contact the bidder department at 480-421-6694 for a Wire Transfer Letter Format or to discuss an alternate method of payment.**
